### **Inclement Weather and Cancellations**

**The \$75 event deposit is non-refundable.**

If the event is canceled due to inclement weather, (as agreed on by both you and a member of BZ) we will work to reschedule the event for the closest convenient time, and reservation deposit shall rollover to the next reservation date. If event is rescheduled a second time a new reservation deposit will be required.

### **Additional Information**

Depending on rental package one or more members of BZ will remain on-site and facilitate games and equipment. Actual play time will follow your package details. If players are in the middle of a game when time expires, we will continue to play until the game is finished.

### **Travel Fees**

Depending on event location there may be an additional Travel Fee assessed. There is no travel fee for 0-25 miles from Rocky Ford, CO. There is a \$25 travel fee for 25-50 miles from Rocky Ford, CO. There is a \$50 travel fee for 50-100 miles from Rocky Ford, CO.

### **COVID-19 Information**

All equipment will be thoroughly sanitized using a CDC recommended sanitizer. We will provide hand sanitizer at the game table for all guests and players. BZ staff will wear a face covering at all times. Indoor events will be limited to the local county gathering limits. Outdoor events will be limited to the local county gathering limits.
